

### INVESTMENT OBJECTIVE

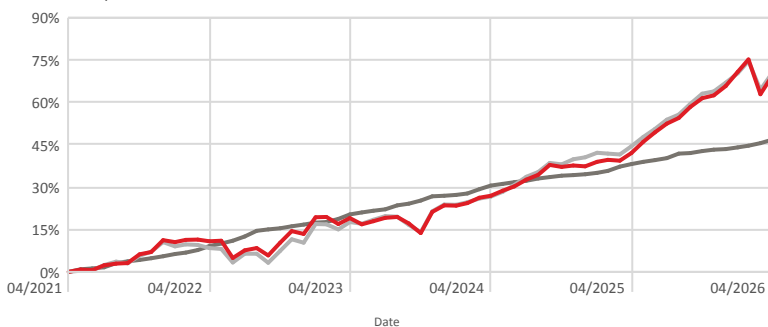
The primary investment objective of the portfolio is to provide the investor with a moderate level of income and capital growth.

### INVESTMENT POLICY

The composition of the portfolio shall reflect the investment structure of a retirement fund and shall comply with prudential guidelines. The underlying portfolios may invest in, amongst others, equity securities, property securities, non-equity securities, interest bearing securities, money market instruments, preference shares, bonds and other interest bearing instruments and securities.

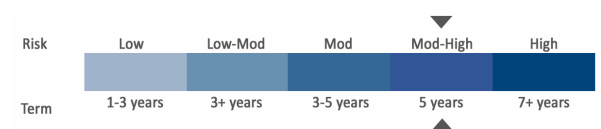
